① Decline in assets reflects Comerica Inc.'s retention of ownership of former Munder unit World Asset Management following Munder's management-led buyout of the company from Comerica on Dec. 29, 2006. Members of the management team partnered with private-equity firm Crestview Partners L.P. to acquire Comerica's majority interest in the firm. As of Dec. 31, 2006, the ownership of Munder Capital Management was as follows: Munder Capital employees own 19.1 percent with an opportunity to increase to approximately 35 percent within five years; Crestview Partners GP L.P. and its affiliates own 69.8 percent; and two other investors own 5.55 percent each.

② World Asset Management, formerly a division of Munder, was incorporated on Sept. 15, 2006, and became wholly-owned subsidiary of Comerica Inc. as of Dec. 29, 2006.
